Now, let me ask the Nebraska Commandery Body a question: Since President Trump, and Governor Ricketts have closed down social gatherings in our state, how many of our Commanderies have attempted to conduct a Stated Conclave? Please let me know as I fear that only one has been conducted. Grand Master S.K. Jeffrey N. Nelson has given us permission to conduct conclaves using technology, in his GENERAL ORDER NO. 12, struck on May 4, 2020 which states "... I do hereby waive the requirement of Section 65 (a) of the Constitution, and authorize the Commander of a Constituent Commandery within each Grand Commandery to convene a Stated Conclave by means of teleconference or webcast, provided that the necessary facilities are widely available to the members of the Constituent Commandery and the Stated Conclave be conducted in full compliance with the requirements of Sections 65 and 66 of the Constitution. Commanders of Subordinate Commanderies enjoy the same discretion."

I recommended, that in the month of June, each Commandery conduct a Stated Conclave by means of teleconference or webcast, provided that GENERAL ORDER NO. 12 is followed and not violated. So to be clear, in GENERAL ORDER NO. 12 where the Grand Master states: "... provided that the necessary facilities are widely available to the members of the Constituent Commandery ...", my recommendation did not allow for excuses like "That would be to hard" or "I do not know what to do". There are many individuals that can assist. For example, our Grand Recorder Dennis Newman and others, including myself, have experience in this area. In fact, this is an excellent opportunity involve our members who either have this experience, or are willing to figure out how to work these online conclaves. This is how we are to operate until GENERAL ORDER NO. 12 is rescinded.

Oh by the way, our meeting was a success! There were many funny stories and jokes told (As Masons are want to do). We all laughed and smiled ... for the ones I could see in the webcast ... quite a bit. And you know, for a moment, COVID-19 no longer existed. All I was doing was having a great time having fellowship with my fellow Sir Knights.
